## BOOTH RULES AND REGULATIONS

### PLEASE READ CAREFULLY BEFORE APPLYING TO THIS SHOW

1. EXHIBITOR MUST USE WHITE OR OFF WHITE OR BLACK TABLE COVERS. NO BEDSHEETS OR PLASTIC. THEY MUST BE DRAPED TO THE FLOOR ON ALL SIDES. A CONTRASTING COLOR MAY BE USED ON THE TABLE TOP. METAL ARTIST'S SCREENS MUST BE COVERED. YOUR DISPLAY MUST BE NEAT AND PROFESSIONAL.
2. DISPLAYS WILL BE REVIEWED THURSDAY MORNING FOR COMPLIANCE TO ALL RULES AND REGULATIONS PUT FORTH BY THE MALL OF GEORGIA AND THE DUNWOODY ARTS & CRAFTS GUILD.
3. BOOTHS MUST BE MANNED AT ALL TIMES BY THE EXHIBITOR AND REMAIN OPEN DURING MALL HOURS. YOU MUST BE OPEN FOR BUSINESS AT 10AM THURS – SAT AND NOON ON SUNDAY.  
NO EXCEPTIONS!
4. DUE TO SAFETY CONSIDERATIONS, CHILDREN ARE NOT ALLOWED TO ACCOMPANY EXHIBITORS IN BOOTHS.
5. ONLY PROFESSIONAL SIGNS WILL BE PERMITTED AT DISPLAYS. NO HAND PRINTED SIGNS. THE MALL RESERVES THE RIGHT TO REMOVE EVEN PROFESSIONAL SIGNS THAT DETRACT FROM THE MALLS DÉCOR OR FROM THE SHOW.
6. EACH BOOTH MUST BE KEPT CLEAN AT ALL TIMES. PLEASE KEEP UNSIGHTLY ITEMS OUT OF SIGHT DURING SHOW. THIS INCLUDES REMOVING BOXES AND PACKING MATERIALS FROM YOUR BOOTH.
